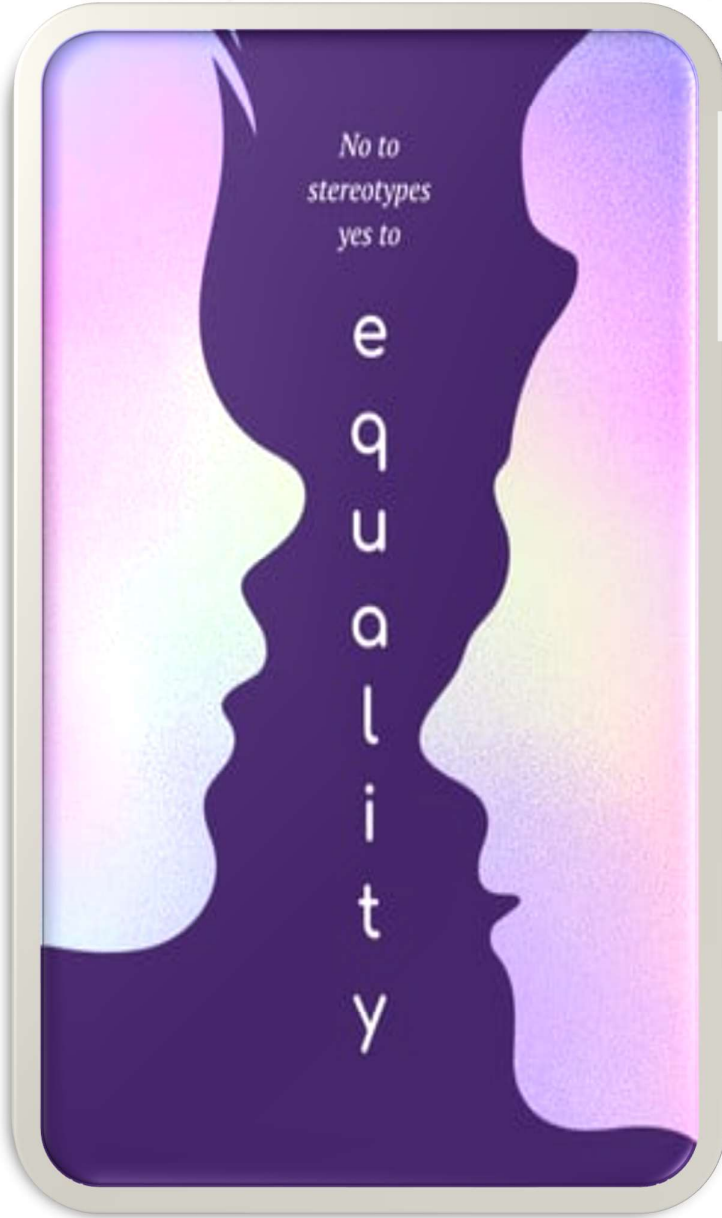

1. Meaning of Gender Audit

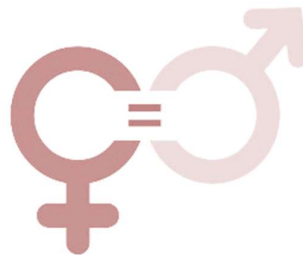

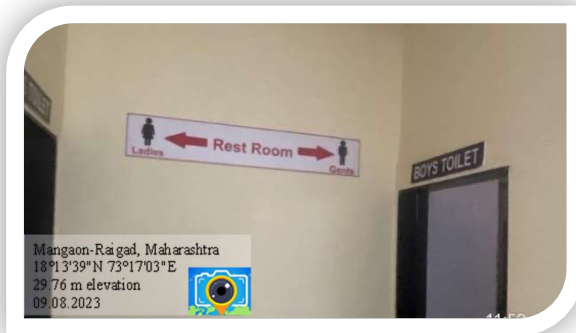
