3. The Context:

Guarantees of free legal aid to poorer part of society has context to the Indian constitution Articles 38 and 39 (A).


Article 38(1) States that State shall provide the social welfare of people.

In 1995, the Legal Services Authorities Act went into force. As per it, free legal services must made available to every Indian who is society and economically poor.

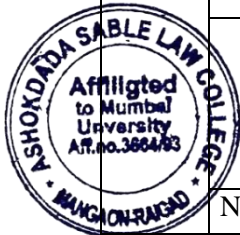

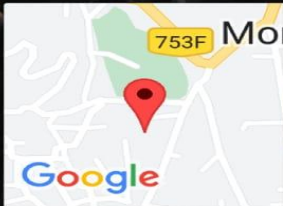
