Mangaonians were and are hard worker. sincere and excited to achieve high goals. In those days, aspirants use to bicycle or walk to reach to Goregaon or Morba for education.

EDUCATION SUN RISES - THE MSPM :

The trust of education increased. Many more aspirants seek interest for high school education. In those days Bran (Food), Yarn (Cloth) and Ashiyan (house) were first priority. Learn (Education) was never on first need side. However, the basic essence of education was waved, increased. Mangaonians felt the need of high school education for brain. Food is need of stomach. blood is need of heart similarly education is need of brain. Higher education in Mangaon was raised by Adv. Sadashiv Kelkar and Dr. Dhansay O. A. Both. these learned personalities laid a foundation stone of HIGH SCHOOL' education in Mangaon. The high school was started under the Mangaon Taluka Shikshan Prasarak Mandal, Goregaon. There was no own space or place for high school. The high school started at somebody's house. It was first ray of education sun in Mangaon horizon.

Eligibility for scholarship / Freeship

SCHOLARSHIP/FREESHIP (SC, ST, NT, DT, SBC & OBC STUDENTS for all Courses)

Eligibility for Scholarship/Free ship only

1. Scholarship for SC/ST Category Family annual Income Limit should be up to 1,00,000/-
2. OBC/NT/DT/SBC Category Family annual Income limit must be between 49,000/- to 65290/- (50%) Scholarship
3. OBC/NT/DT/SBC Category Family annual Income limit must be below 49,000/- (100%) Scholarship
4. Students from OBC/NT/DT/SBC Category Income above 65,290/- will get Free Ship. 5. The students from other than Maharashtra state are not eligible for Scholarship / freeship schemes.

(Other state Eligibility case.) The candidates who want to claim free ship should submit the following documents at the time of admission.

PROCEDURE FOR APPLYING An application for scholarship should comprise

- (1) One copy of the application for scholarship in the prescribed form (separate Application forms have been prescribed for fresh, and renewal scholarship)
- (2) One copy of the passport size photograph with signature of the candidate thereon (for fresh scholarship)
- (3) One attested copy of certificates. Diploma, Degree etc in respect of all examinations passed.
- (4) One photocopy of Caste certificate: Original Caste certificate issued and duly signed by an authorized Revenue Officer not below the rank of Tahsildar.

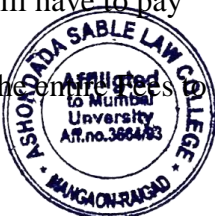

1. Objective

The purpose of this policy is to provide financial assistance to students from economically disadvantaged backgrounds, empowering them to pursue their studies without the barrier of financial constraints. This policy is aimed at promoting educational access, inclusivity, and academic excellence.

2. Types of Freeship Offered

- **Full Freeship:** Complete waiver of tuition fees for the academic year.
- **Partial Freeship:** Partial waiver of tuition fees (50% or more) based on the student's financial need and academic performance.

3. Eligibility Criteria

To qualify for the freeship, students must meet the following criteria:

- **Financial Need:**
 - The student's family income must be below a specified threshold (e.g., below ₹1,50,000 annually).
 - Verification of family income through recent income certificates, tax returns, or other relevant documents.

- **Academic Performance:**

- For incoming students: High academic performance in entrance exams or previous qualifying exams.
- For continuing students: A minimum GPA or percentage (e.g., 3.0 GPA on a 4.0 scale or 70%) in previous semesters.

- **Disciplinary Record:**

- The student must have a clean disciplinary record and adhere to the institute's code of conduct.

4. Application Process

- **Step 1:** Fill out the Freeship Application Form available at the institute's scholarship or financial aid office or on the official website.
- **Step 2:** Submit the required supporting documents:
 - Income verification documents (income certificate, tax returns, etc.).

6. Renewal of Freeship

- Freeships are granted on an annual basis. Students who wish to renew their freeship must reapply each academic year and provide updated financial and academic records.
- Renewal is contingent on the student maintaining the required academic performance and adhering to the institute's code of conduct.
- Any significant changes in the student's financial situation must be reported to the financial aid committee.

7. Terms and Conditions

- **Minimum Academic Requirement:** Students must maintain a GPA of at least 3.0 (or equivalent percentage) each semester.

- The committee will review appeals on a case-by-case basis, and their decision is final.

9. Confidentiality

- All personal and financial information submitted as part of the freeship application process will be kept confidential and only accessed by the financial aid committee for assessment purposes.

10. Policy Review

- This policy will be reviewed annually by the institute's financial aid committee to ensure fairness, relevance, and compliance with the institute's mission and goals.
