Two lifts and one staircase for easy dispersal of children during any emergency. Each

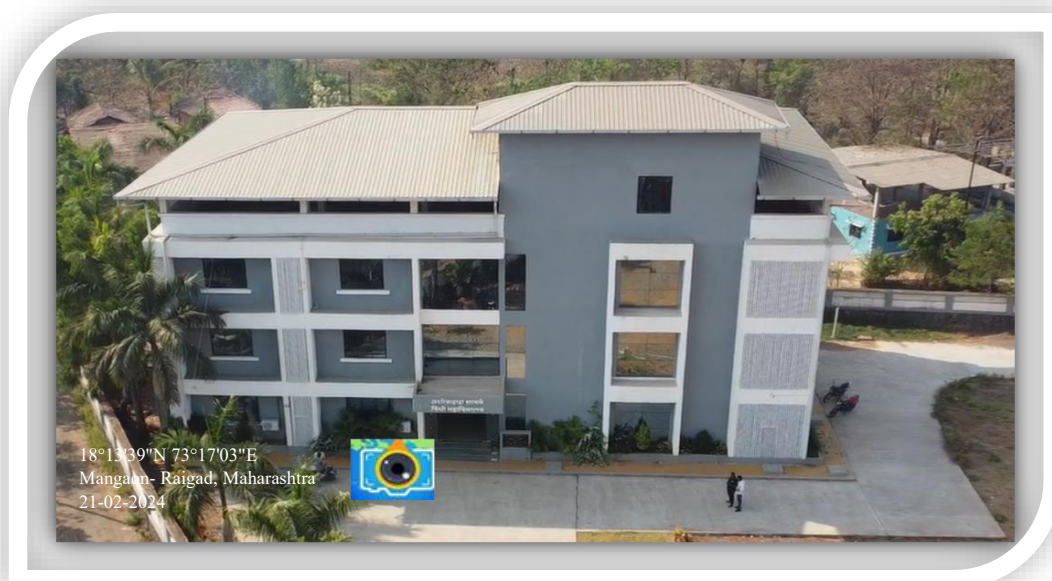
floor has washroom and washbasin with water filter (aqua guard) at each floor.

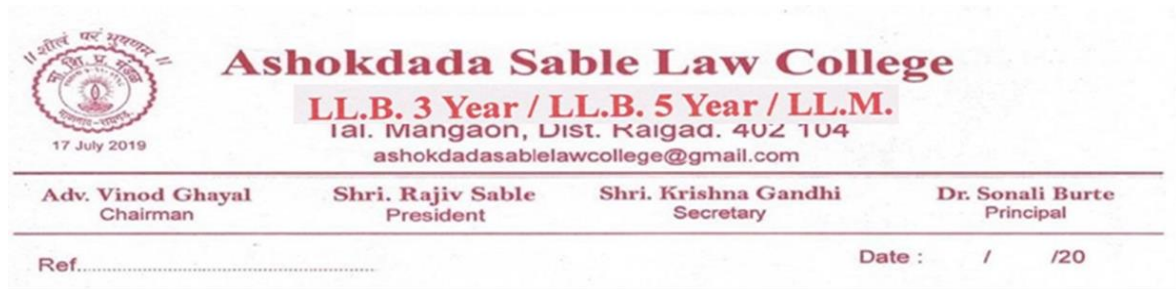
## 11. THE AUDIT STAGE

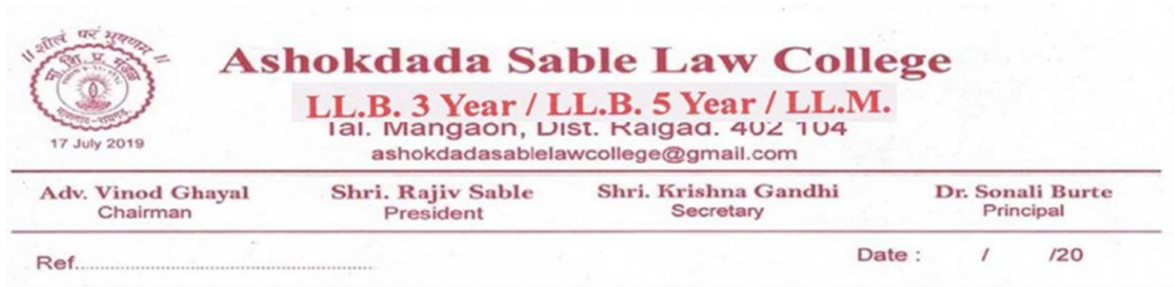

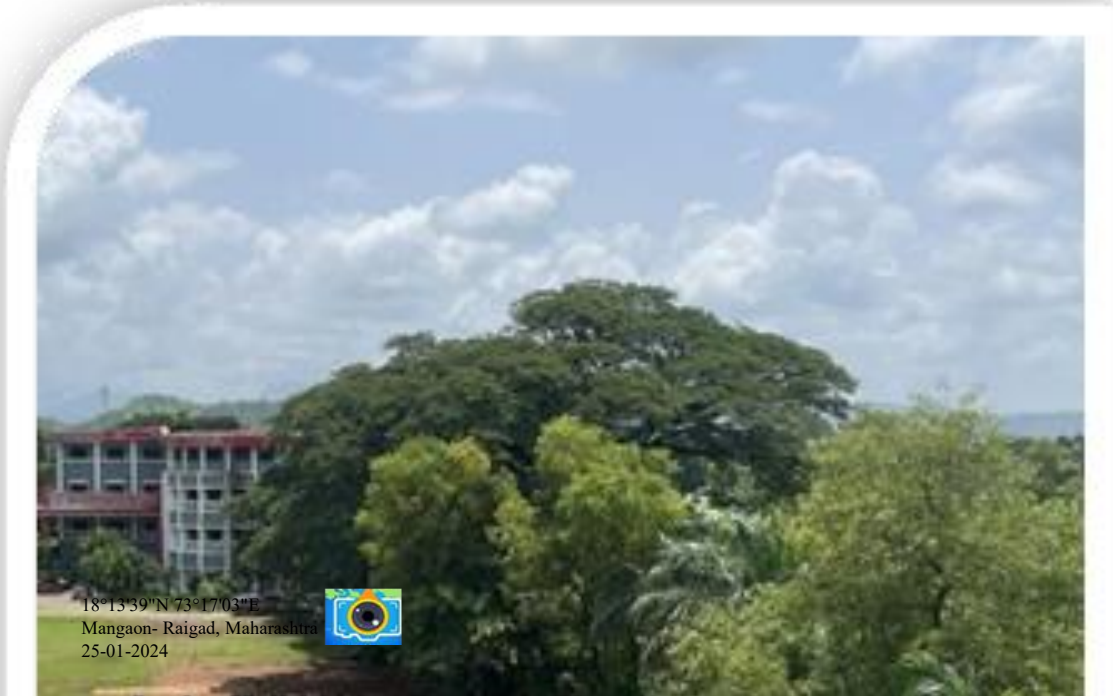
